LESS THAN 37.5 KVA SINGLE-PHASE SERVICE
RATE 10, 118 & 316**

ELIGIBILITY—Eligible for locations served by Barry Electric Cooperative, subject to the Cooperative's service rules and regulations.

APPLICABILITY—Applicable for all single-phase service, provided it is individually metered.

TYPE OF SERVICE (single-phase transformer prorated size less than 37.5 kVA)—Single-phase, 60 hertz at 120/240 volts.

The billing period is approximately thirty (30) days traditionally or daily through voluntary Prepay Billing. Charges herein may be prorated.

DEMAND CHARGES—The On-Peak and Off-Peak Charges stated above shall be applied to the member's peak kilowatts per month whereby the peak kilowatts fall in their respective Time Periods.

TIME PERIODS—The following time periods are expressed in terms of the prevailing Central Standard Time:

On-Peak Hours—On-Peak Hours are the hours beginning at 7:00 a.m. and ending at 8:00 a.m. as well as beginning at 2:00 p.m. and ending at 6:00 p.m., Monday through Friday, during the calendar months of January through December, excluding Thanksgiving Day and Christmas Day.

Off-Peak Hours—Off-Peak Hours are all hours not defined herein as On-Peak Hours.

TERMS OF MONTHLY VS. PREPAY PAYMENT—Monthly payment is due no later than the 25th of each month. If the account is not paid by the due date, a late fee specified below may be added to the account. Payments are required, to maintain a credit balance, on accounts enrolled in Prepay.
